

## **Program Agreement**

**THIS AGREEMENT** is made and entered into this 12 day of May, 2022, by and between **COLLEGE OF SOUTHERN MARYLAND** (hereinafter the “College”), and **THE JOHNS HOPKINS HOSPITAL on behalf of the JOHNS HOPKINS SCHOOLS OF MEDICAL IMAGING** (hereinafter “Johns Hopkins”), a tax exempt Maryland corporation.

### **RECITALS**

**WHEREAS**, the College has an undergraduate curriculum that can serve as a prerequisite to certification in Radiological Sciences; and

**WHEREAS**, Johns Hopkins offers a certificate program in Radiography consisting of classroom and clinical components; and

**WHEREAS**, the College and Johns Hopkins desire to collaborate to permit College students interested in a career in Radiography to complete applicable academic prerequisites at the College, and their classwork and clinical work at Johns Hopkins to obtain both a certificate in Radiography from Johns Hopkins and an associate degree from the College; and

**NOW, THEREFORE**, in consideration of the mutual agreement set forth herein, the College and the Program will cooperate as hereinafter described.

### **THE COLLEGE**

1. The College will provide the educational prerequisites for admission to the Johns Hopkins Radiography Program as required by the Joint Review Committees on Education in Radiologic Technology (“JRCERT”). The College’s current education plan for Radiography students is set forth on **Exhibit A** which is attached hereto and incorporated herein.
2. The College will award an associate degree to each student who successfully completes the requirements of the College and the Johns Hopkins Radiography Program.
3. The criteria for admission to the College will be determined by the College.
4. A faculty member or the Health Sciences Advisor at the College will function as the Program Coordinator and will work with the Radiography Program Director from Johns Hopkins. The two will form a Radiography Advisory Group consisting of members of both institutions to assume oversight of the curriculum, student admission and advising, and program assessment.
5. The Radiography Advisory Group shall meet at least annually to conduct curriculum review, program development and evaluation, and to ensure compliance with JRCERT standards. There shall be periodic meetings of the Program Coordinator for the College and the Program Director for Johns Hopkins (and/or their respective designees).
6. The College will list the name of the Johns Hopkins Radiography Program in the College catalog, College Transfer Services webpage, and other appropriate brochures and

materials. The College will not use or publish the name of Johns Hopkins or use its logo or any images of its campus or employees for any other purpose without the written permission of Johns Hopkins, which permission may be granted or denied in Johns Hopkins' sole discretion.

7. The College will assist in the distribution of brochures, catalogs, applications, and other materials to student aspirants in Radiological Sciences.

### **JOHNS HOPKINS**

1. Johns Hopkins will provide a curriculum in radiological sciences which meets the accreditation requirements of the JRCERT.
2. Johns Hopkins will provide the physical facilities and equipment necessary to conduct the clinical portion of the Radiography Program.
3. Johns Hopkins will be solely responsible for setting its admission and screening criteria and for making admission decisions to its Radiography Program, so long as consistent with JRCERT accreditation standards.
4. Johns Hopkins will provide the College with student grades within 3 weeks of completion of each semester of the Radiography Program by submitting an official transcript to the College.
5. Johns Hopkins will establish annually a schedule of tuition and other fees and communicate this information to the College.
6. In the event of an emergency while students are on site at Johns Hopkins, Johns Hopkins will see that emergency care is provided through the students' medical insurance coverage. With the exception of emergency care, the Students will provide for their own medical care needs.
7. Johns Hopkins will award a certificate upon satisfactory completion of the clinical internship.
8. Johns Hopkins will provide or refer students for counseling during their participation in the Radiography Program as needed.

### **MUTUAL PROVISIONS**

1. The grading policy will be such that while the student is at the College the grading procedure will be that of the College; while the student is at Johns Hopkins, the grading procedure will be that of Johns Hopkins. Determination of failure and right to repeat will be made by the institution at which the student has registered for the course(s) in question.
2. Johns Hopkins and the College agree to continue their respective policies of nondiscrimination based on Title VI of the Civil Rights Act of 1964 in regard to sex, age, race, color, creed, national origin, Title IX of the Education Amendments of 1972 and other applicable laws, as well as the provisions of the Americans with Disabilities Act.

3. Each party agrees to perform their responsibilities hereunder in accordance with all applicable laws and regulations, including without limitation, the Family Educational Rights and Privacy Act, and requirements of applicable accrediting bodies.
4. Each party agrees to advise the other promptly of any changes in its personnel, operation, or policies which may affect students' academic and/or clinical experience.
5. This Agreement shall commence as of the date set forth above, and shall remain in effect for a period of five (5) years unless earlier terminated as provided herein. This Agreement may be renewed upon mutual written agreement of the parties. This Agreement may be terminated by either party upon one (1) year prior written notice to the other. In the event of a material breach by a party, the non-breaching party may terminate this Agreement upon thirty (30) days prior written notice to the other party, and failure of the breaching party to cure or make substantial progress towards a cure within the aforementioned notice period. The parties will work cooperatively to permit students enrolled prior to termination to complete the program.
6. Each party shall be responsible for its own acts and omission, and the acts and omissions of its employees, faculty, and agents. Neither Johns Hopkins nor the College assumes responsibility or liability to the other for any loss, damage to property or personal injuries (including death) unless specifically stated in this Agreement.
7. This Agreement may not be assigned, modified, or altered in whole or in part, without the prior written consent of both parties.
8. This Agreement constitutes the entire understanding between the parties hereto, shall be governed by and construed in accordance with the laws of the State of Maryland (excepting any conflict of laws provisions which would serve to defeat application of Maryland substantive law), and shall be binding upon and inure to the benefit of the respective successors and assigns of the parties hereto. EACH PARTY, KNOWINGLY AND AFTER CONSULTATION WITH COUNSEL, FOR ITSELF, ITS SUCCESSORS AND ASSIGNS, WAIVES ALL RIGHT TO TRIAL BY JURY OF ANY CLAIM ARISING WITH RESPECT TO THIS AGREEMENT OR ANY MATTER RELATED IN ANY WAY THERETO.
9. Notices. All notices required to be given hereunder shall be in writing and shall be sent by certified mail, return receipt requested, postage prepaid, addressed as follows:
