V. FACULTY COMPENSATION STUDY

Ron Price, Vice President, Division of People, Culture & Equity, and Michael Misrahi, a representative from Evergreen, presented the Faculty Compensation Study with recommendations for full-time & part-time faculty compensation rates

Trustee Allen made a motion to approve the recommendation to increase all full-time faculty using the progression and parity (Hybrid Approach) method. Costs excluding benefits and taxes, are \$488,460. Trustee Cox Seconded
